A message from our CEO

A busy month with our end-of-financialyear audit, AGM and a Board meeting yesterday, on top of meetings with Kainga Ora, the Abuse-in-Care team, trips to participate in regional provider network meetings in Nelson and Auckland, and (of course!) pay equity!

Firstly, let me congratulate Catherine Bennett and Sarah Hillier on their election to the NZDSN Board. And our thanks to retiring Board members John Taylor and our past Chair Sean Stowers.

The Board, at their first meeting post the AGM, have elected Jonathan Mosen (Workbridge) and Pip Stewart (Brackenridge) as incoming Chair and Deputy Chair.

We await the report from the Abuse-in-Care Royal Commission and anticipate this will be a critical and sobering read. It will present recommendations that impact on our sector, so we need to be prepared and (where possible) ensure our voice is heard and taken into account in the final drafting of these recommendations. There is no room in our sector for abuse or neglect of disabled people receiving our support. At the same time, the restrictions placed Jonathan Mosen environment of significant underinvestment has to be seen as a major contributing Paper closed in March this year. The Law Commission had been targeting this October for release of their Second Issues Paper. They have now decided to release it in January next year.

The Second Issues Paper will ask about proposed options for reform. This revised timing reflects the wide scope of the review, the complexity of the policy work involved in developing these options, and the importance of facilitating engagement on them by a wide range of stakeholders.

In light of this revised timing, the Commission now intend to deliver their final report to the Minister by the end of 2024.

We will let you know when the Second Issues Paper is published next January. The consultation period is expected to be about ten weeks, primarily in February and March. NZDSN will be soliciting views on this Second Issues Paper as part of Review from members the and submitting on your behalf.
